1. INTRODUCTION

Welcome to the NWK Market Privacy policy. We take your privacy very seriously and being compliant with the GDPR is a top priority for us.

This privacy policy web portallies between you, the user/merchant of this NWK Market Web Portal and NWK Technologies Ltd, the owner and provider of this Web portal. This privacy policy to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

This page informs you of our policies regarding the collection, use and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, the terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

- The headings and sub-headings do not form part of this privacy policy.

3. SCOPE OF THIS PRIVACY POLICY

15. DATA RETENTION

Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until we receive your request that the Data be deleted.

We will make sure that once we receive your request to cancel your information will be cancelled. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

16. YOUR RIGHTS

You have the following rights in relation to your Data:
